GEAR UP:



2019-2020 PLANNING & New Graduation Requirements:

Shared this at a recent staff meeting!

E2SHB 1599 modifies graduation requirements and includes the expedited appeal process for the class of 2019. This bill has passed both houses in slightly different forms, so it is waiting to go through the "concurrence" process to have agreement on the final language. I have been assured that this will happen and I know that many of you in high schools are anxious about your current seniors as well as planning for next year's staffing and master schedule. OSPI is planning to release information next week about this bill and its implications.

This bill will:

- Remove the requirement that students receive a certificate of academic achievement to graduate, beginning with the class of 2020.
- Modify provisions relating to high school and beyond plans.
- Remove testing requirements for high school graduation.
- Replace certain graduation requirements with pathway framework. Y
- Extend, through the class of 2020, an expedited appeal process for waiving assessment requirements.
- Direct OSPI to facilitate the creation of a statewide online platform for high school and beyond plans.
- Require the State Board of Education to convene a work group on mastery-based learning.

SEL (SB 5082 | Social emotional learning): Character Strong

ON the Horizon....

Summary of Bill (Second Substitute): A committee is created to promote and expand SEL, subject to appropriation. SEL will help students build awareness and skills in managing emotions, setting goals, establishing relationships, and making responsible decisions that support success in school and life. The SEL Committee must:

Ÿ develop and implement a statewide framework for SEL that is trauma-informed, culturally sustaining, and developmentally appropriate;
