# Enrichment Levy, Capital Projects Levy, & Transportation Vehicle Levy

The deadline for the February 2020 special election resolutions to be submitted to the Lincoln County Auditor's Office is December 13. I've attached a copy of our levy newsletter that was mailed in January 2018 for your reference as we begin our discussions and planning.

#### <u>Update: Facility Grants – Good News and Not So Good News</u>

**Good News**: we received the **planning grant** for our grant proposal to put a new HVAC system in the high school gym and to replace our high school boilers.

Not So Good News: We were not awarded a CTE equipment grant ---we had applied for this grant to assist with work needing to be completed inside our construction trades building. We are actively pursuing other grant opportunities.

# **Legislative Update/Preview:**

During the WSSDA Conference, I attend a legislative update session featuring Senators Lisa Wellman and Mark Mullet. It appears as though the upcoming legislative session will be primarily focused on how our lawmakers will deal with budget shortfalls in the transportation budget as a result of the recent vehicle license tab initiative. I've attached a copy of a one-page handout that Cal Brodie (Chief Financial Officer at ESD 113) & I presented during a breakout session at the conference.

# Hold-Harmless Discussions – WSSDA Conference Small School Forum - Nov. 23, 2019

#### Jim Kowalkowski & Cal Brodie

- > Post McCleary: "Houston Olympia, we have a problem!
  - Reduction in local levies
  - Reduction in LEA funding
  - Loss of SAM/Staff Mix
  - Much of the new money went for regionalization & experience factor—limited number of districts...many more losers than winners.
- ➤ WASA Work group formed with a focus on a "short-term bridge" to a "future legislative funding fix":

#### **Proposed Solutions:**

- Recommended assistance to 115 school districts
- Also recommended expanding the "experience factor" criteria by 15%...would have provided additional funding to 52 additional districts

#### Challenges:

- "You guys are not being honest..." we don't trust your numbers."
- "We just passed huge increases in K-12 funding...you guys will never be satisfied."

#### Champions:

- WASA, WSSDA, WASBO, ESD's & REC (Rural Ed. Center)
- Gavin Hottman & Tom Fleming
- Rep. Mike Steele
- ➤ HB 2163 passed by 2019 Legislature
  - \$42.6 million hold harmless funding allocated for 19-20 (83 districts)
  - \$11..8 million for 20-21 (only 15 districts)
- ➤ "Moving Parts" <u>Five</u> Important Things to Pay Attention to Your District
  - Hold Harmless
  - Salary funding for:
    - o Regionalization
    - o Experience 1.04%
  - Levy/ LEA Proposals
  - Overall inequity.
